

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The portion of Crown Hill Cemetery nominated for inclusion in the National Register comprises approximately 3.74 acres lying about three miles north of the center of the city and within the present city limits. The winding roads of the cemetery grounds lead through a natural and informal pattern of grassy meadows and clumps of trees and shrubbery of a wide variety of species. Near the center of the west boundary the road ascends a low hill of a hundred feet or more, known as Crown Hill, from which the cemetery takes its name. The remainder of the terrain surrounding the hill is generally level ground.

The main entrance to the cemetery is by means of elaborate iron gates in the three Gothic arches of the imposing gray limestone Gateway near the middle of the east boundary. Just within the Gateway lies the one-story red brick Office Building with its gray limestone trim and tower.

About 2,000 feet west of the Gateway is situated the Chapel, an earlier building with gray limestone walls and gray limestone vaulted main interior space.

STATEMENT OF SIGNIFICANCE

The cemetery is significant for its landscaping, being an excellent example of Romantic Landscape Design in the Olmstead tradition.

The cemetery is also significant for the architectural nature of the structures mentioned in Section 7. Both Gateway and Office Building are in the High Victorian Gothic style of architecture; both were built in 1885, and both are the designs of Adolf Scherrer, an Indianapolis architect born in Sanct Gallen, Switzerland, and educated in Europe. The Office Building is noteworthy as well for its rich interior ornament.

The Chapel, built from 1875 to 1877, is also in the High Victorian Gothic style. Its designer, D. A. Bohlen, was also an Indianapolis architect, of German birth and education. In 1917 D. A. Bohlen & Son were the architects chosen to add the apse to the Chapel.

The graves themselves are of great significance both to the cemetery and to Indianapolis, for many historically important people are buried there. At the level of national importance is the grave of President Benjamin Harrison, and the graves of three Vice-Presidents. In addition, after 1864 when the cemetery was dedicated, it found itself considered the most fashionable burying ground in the community, and graves of most of the prominent people of Indianapolis are found there. A small portion of Crown Hill Cemetery is also a United States National Military Cemetery, established in 1866, and containing some seven hundred graves of soldiers of the Civil War and of subsequent wars, and of one drummer boy who died in the American Revolution.

The hill is crowned by a memorial to the poet James Whitcomb Riley.






